Session: Admissions & Appeals Delivered by: Diocese Suitable for: All Governors/Directors

In partnership with the Catholic Education Service and the Catholic Teaching Schools Alliance, the Diocese have designed a portfolio of online training for the induction and development of governors in Catholic schools.

Session: Catering in our schools Delivered by: Catering Team Suitable for: All Governors/Directors

This session provides an insight in to the work of Chadwick's Kitchen the Trust catering team. It looks at how menus are created and the considerations in providing our pupils and staff with nutritious, good value meals, including medical diets and food miles.

Session: Catholic School Inspection Delivered by: Diocese Suitable for: Chairs / All Governors/Directors

This session will give an overview of the new CSI framework and discuss the role of goverrnors. Examples of dialogue will be given and those attending will have more confidence in supporting their school during an inspection.

Session: Health & Safety Delivered by: Estates Team Suitable for: All Governors/Directors

This session provides an outline of the H&S legislation applicable to a school and their responsibilities, including those of a school Governor and useful links/references to manage these responsibilities.



Session: Introduction to Mental Health Training Delivered by: Mental Health Coordinator Suitable for: All Governors/Directors

You will gain an understanding of the Mental Health provision across our Trust, and, our commitment to improving both reactive and proactive support for students, staff and the wider community. We will cover the bronze, silver and gold Mental Health Charter marks we are striving towards achieving as a whole Trust, and how our governors can become involved and support with this.

Session: New Governor Training Delivered by: Diocese Suitable for: New Governors

This is a **mandatory** training session for all NEW governors/Directors. A really useful session with an opportunity to ask questions about your new role whilst covering the basics of the role of governor

Session: New Governor Safeguarding Delivered by: Clennell Suitable for: New Governors / Directors

This is a **mandatory** training session for all governors/Directors to understand the new requirements with 'Keeping Children Safe in Education' legislation.Those who attend the session will know and understand the guidance as outlined in the legislation and the actions they need to take as governors to ensure this is applied in school.

Session: New to SEND Delivered by: SEND Director

Suitable for: SEND Link Governors/All Governors/Directors

This session will enable governors/Directors to understand the key roles and responsibilities of the SEND Governor, what schools and academies are required to do to meet the needs of children and young people with SEND, understand what inclusive practice means in a school setting and know what the key legislation relating to SEND is and where to find it.

Session: SEND Network Delivered by: SEND Director Suitable for: SEND Link Governors/Director

This is a supportive networking group for all govenors linked with this important area. Sessions will comprise important updates, particular areas of focus and time to share best practice and collaborate.

Session: Risk Management (Risk Register) Delivered by: Finance Team Suitable for: All Governors/Directors

This session will support governors in understanding the LGC's role in the health and safety of their school. It will consider: the duties of the LGC and the areas covered by this legislation; policy and risk assessment requirements; and practical suggestions around monitoring this area.

Session: RE & RSHE Delivered by: Diocese Suitable for: All Governors

Session: Single Central Record Delivered by: People Team

Suitable for: Chairs/Safeguarding Link Governors/Directors

This session supports governors to understand the purpose of the single central record, the relevant legislation and any potential risks. Those who attend the session will be able to understand the relevant guidance as outlined in 'Keeping Children Safe in Education' and how these requirements are applied in the Trust.

Session: Safer Recruitment Delivered by: People Team / Clennell Suitable for: Chairs / Vice-Chairs / Governors/Directors involved in recruitment

This is a full day of training comprising a number of sessions focusing on all aspects of safer recruitment. There is a requirement to ensure a recruiment panel has representation from people who have undergone this training. Those who attend will be certified as 'Safer Recruitment' trained for the purposes of these panels.

Recommended that training is completed every 3 years

Session: Safer Recruitment Refresher Training
Delivered by: People Team/Clennell
Suitable for: Chairs / Vice-Chairs / Governors / Directors
who have previously completed the Safter Recruitment
full day training course, within the last 5 years.



Session: Safeguarding Refresher Delivered by: Clennell Suitable for: All Governors / Directors

This is a **mandatory** training session for ALL governors/Directors each year to understand the new requirements with 'Keeping Children Safe in Education' legislation. Those who attend the session will know and understand the guidance as outlined in the legislation and the actions they need to take as governors to ensure this is applied in school.

Session: Understanding Academy Finance Delivered by: Finance Team Suitable for: All Governors/Chairs

This course is intended to help Governors understand their role and responsibility re thefinancial management of their trust/academy; how academies are funded and the academy budget setting process; the "musts" per the Academy Trust Handbook; how best to providesupport and challenge to academy leaders re financial governance.

Session: Understanding Appraisals Delivered by: People Team Suitable for: Chairs/Directors

This session supports chairs and directors to understand the Trust guidelines on Appraisals for teaching and support staff and the statutory requirements linked to Appraisals for teachers/ Headteachers. Those who attend the session will be able to understand the Appraisal process including reviewing the previous year, objective setting, performance related pay where appropriate and the link with the Capability Policy. Session: Understanding the Ofsted Framework (Effective Support and Challenge)
Delivered by: School Improvement Team
Suitable for: Chairs & Vice-Chairs/All Governors

This session will unpick the knowledge, skills and behaviours needed for effective governance and provide Governors/Directors with a clear understanding of the current Ofsted framework for leaders and governors. Governors will be prepared to hold leaders to account for the educational performance of the school and its pupils, and to support the school to provide a high-quality education for its pupils.
